

Updated Executive Officer Notice: Specimen Collection for COVID-19 Testing of At-Risk Asymptomatic Persons through Ontario Pharmacies: Eligibility Criteria

August 27, 2021

This Executive Officer Notice replaces the previous Executive Officer (EO) notice with regard to patient eligibility for pharmacy services related to COVID-19 PCR testing that was effective May 31, 2021. Updates in this notice provide important information relating to Patient Eligibility and Investigation Numbers.

Patient Eligibility – Effective August 27, 2021

Individuals are eligible for pharmacy services related to COVID-19 PCR testing if they are:

- asymptomatic for COVID-19 (i.e. not showing symptoms);
- have had no close contact to someone who is confirmed as having COVID-19 (regardless of vaccination status);
- have not received a positive point-of-care test (POCT) result, including a positive result obtained from a POCT kit used at home;
- not part of a specific outbreak investigation; and
- part of a targeted testing campaign by the Ministry of Health, Ministry of Long-Term Care, Ministry of Seniors and Accessibility or a local public health unit (see list below).

Please note that these criteria may change from time to time as the pandemic response evolves in the province. The most up-to-date information for pharmacies regarding patient eligibility will be included in this EO Notice, as updated from time to time.

As of **August 27, 2021**, the following population groups are part of a targeted testing campaign:

1. Workers (including support workers), visitors (including caregivers) and government inspectors of long-term care homes;
2. Temporary Foreign Workers;
3. Individuals who self-identify as Indigenous;
4. Individuals, and one accompanying caregiver, with written prior approval for out-of-country medical services from the General Manager, OHIP;

5. Individuals who are travelling into remote/isolated First Nation and Indigenous communities for work purposes; and
6. Until September 6th, 2021, pre-camp testing for campers and staff attending overnight summer camps.

Eligibility includes individuals who are eligible Ontario Drug Benefit (ODB) recipients, non-ODB recipients and those without Ontario health card numbers. No eligible person will be charged for pharmacy services related to PCR COVID-19 laboratory testing, even if they do not have an Ontario health card.

Investigation Numbers

In order to successfully monitor COVID-19 rates of infection in long-term care homes, a list of Investigation Numbers associated with each of these target settings has been assigned by the Public Health Ontario Laboratory. This list will be made available to participating pharmacies.

It is **mandatory** for pharmacists to include the applicable Investigation Number on the laboratory requisition forms for the following individuals:

- Residents, workers (including support workers), visitors (including caregivers) and government inspectors of long-term care homes.

Individuals should be reminded to provide the name of their long-term care home when booking and attending their appointment to facilitate this process. Pharmacies must cross-reference the information provided by the individual with the lists of target settings provided by the Ministry of Health to confirm the individual's eligibility.

The list of Investigation Numbers may be subject to change. The ministry will notify pharmacies of any changes.

Background

As of **September 25, 2020**, select pharmacies are eligible to provide specimen collection for PCR COVID-19 laboratory testing at no cost to eligible persons, if certain terms and conditions are met.

As of December 11, 2020, individuals who require a COVID-19 test for international travel clearance purposes **no** longer qualify for publicly funded pharmacy services related to PCR COVID-19 laboratory testing or publicly funded PCR COVID-19 testing at an assessment centre.

As of June 30th, 2021, students and staff of Ontario elementary and secondary public and private schools (including school bus drivers, supply and specialty teachers) and school

boards **no** longer qualify for publicly funded pharmacy services related to PCR COVID-19 laboratory testing

As of August 25th, 2021, per the latest [COVID-19 Provincial Testing Guidance](#), testing guidance has evolved to compliment Ontario's vaccination program. While the following individuals no longer qualify for publicly funded pharmacy services related to PCR COVID-19 laboratory testing, organizations are eligible for publicly funded testing services through other provincial programs, including the [Provincial Antigen Screening Program](#).

1. Residents, workers (including support workers), visitors (including caregivers) and government inspectors of retirement homes;
2. Residents or workers in homeless shelters or other congregate settings;
3. International students who have passed their 14-day quarantine period; and
4. Children and staff of child care settings.
